# Requirements

The requirements for submission are as follows:

- In order to give the opportunity to new proposals, artists who have exhibited at the Foundation may do so again, only after 30 months from the date of their exhibition.
- The project must be submitted via email in <u>a single PDF file</u> that will be sent to **fundacionrd@fundacionrd.com.ar** and contain:
  - Personal data of the artist or members of the group: name and surname, identity card, date and place of birth, nationality, contact details (phone number and email address), photograph of the artist/s, among others.
  - Explanatory memory, with the concepts that generated the idea, work or project. A text of up to 250 words that conceptualises the work and provides the necessary information for its correct understanding.
  - Photographs that reliably correspond to the exhibition or project, of one hundred percent (100%) of the graphic work. Each image of the project must include information on each of the works: Name of the work, Size, Type of work to be exhibited, Year of production and Technique used, detailing the support and mounting requirements. In the case of the use of non-traditional materials or means of expression, the weight, support, material, etc. must be specified.
  - If the artist or group considers it necessary to include web pages or other links that extend the information requested, they may do so in the body of the message corresponding to the sending of the file.
  - The artist's curriculum vitae or the collective's trajectory detailing training, individual and/or collective exhibitions, awards, other participations and any other information considered of interest for the purposes of evaluating the proposal and the author's merits.

- The projects must comply with the available mounting systems. If the proposal requires electronic equipment not owned by the Foundation, this must be provided by the proposer. The Foundation does not undertake to supply said equipment, nor does it assume responsibility for equipment on loan.
- It is not allowed to drill the walls or to intervene in the painting of the room.
- The proposed works must have the necessary supports for mounting and be ready to hang. The venue will provide its exhibition room and material for the assembly, which will be carried out under the supervision of specialised personnel.
- The artist and/or his/her curator or coordinator must work in collaboration with the staff of the Cultural Centre, following the guidelines indicated by the latter.

## **Evaluation of proposals**

The proposals will be evaluated by the team of Cultural Advisors at the Foundation and their decisions will be final.

These decisions will be officially communicated by the Manager of the Institution. Subsequently, those selected will be contacted in order to adjust their participation in the following year's agenda.

## Obligations of the artists

- The artists must comply with the deadlines established for the call, as well as, subsequently, with the agreed deadlines for the delivery of written material for catalogues, press releases, invitations, and also for the assembly of the works. No material may be distributed unless it has been previously reviewed and authorised by the Foundation.
- When the date of the exhibition is confirmed, the artists or their legal representatives must sign a document/contract that will be considered a sworn statement.
- As the Foundation is a non-profit institution, which does not receive any subsidy or official contribution, the artists are asked to contribute to the operating costs of the exhibition. The amount will be informed in the on-site exhibition regulations, which will be provided after the selection.
- As there is no storage space for the works, participants commit to withdraw them as soon as possible after the exhibition is over.

## **Obligations of the Foundation**

- The Foundation will make it possible for candidates to visit its headquarters, by appointment, in order to see the space for the preparation of proposals.
- The Foundation will take all precautionary measures to ensure that the works are returned in the same condition in which they were received, but will not be responsible for any damage, theft or loss caused during transport.
- The Foundation reserves the right of curatorship whenever it deems it necessary and, in the case of collective exhibitions, the right to decide the rooms where each of the participants' work of will be exhibited.

- The Manager and the Advisors will resolve any unforeseen situations that may arise.



The Foundation does not have sound equipment. In case it is necessary, the musician or group must provide it.

There are no lights in the space either. There is special lighting for the art exhibitions on display in the rooms.

The internal space is small, intimate and suitable for presentations by small groups. The capacity of the internal room is approximately 35 people. Performances can also be held in the garden, which is larger in size, provided that the weather conditions are suitable.

If the musical proposal is with many musicians and instruments on stage and requires a large space with other acoustics, the hall of the Swiss Guillermo Tell Association, with which the Foundation has a collaboration agreement, can be used. It has 80 seats.

This Association charges a room rental. Therefore, the musicians and/or their directors or representatives must commit themselves together with the Foundation to carry out the necessary work to cover all the expenses, either through the sale of tickets or to cover the requested cachet, sound and lighting budget, etc.

The Foundation will not pay for transportation, per diems, or cachet. However, it will take care of the diffusion in the media, in the web pages, in the social networks and will send invitations for the presentation of the event by electronic means.
